Reservation Terms & Conditions

The Fine Print — Booking Terms and Conditions:

Thank you for choosing to stay at Tweed Coast Holiday Parks — Kingscliff Beach. We are looking forward to seeing you here and want your stay to be enjoyable and memorable. To help things run as smooth as can be, please take a few minutes to read our booking terms and conditions.

By paying a deposit you accept your booking and agree with these terms and conditions.

Check-in and Check-out:

Check-in:

Cabins & Ensuite Sites - 2pm; All other sites - 12 noon NSW time.

Check-out: 10am NSW time.

Late Check Out: Please check with office staff. Charges may apply.

Reception hours: 7am - 7pm NSW time.

*Christmas day reception hours 7am-2pm NSW time.

Please advise reception if you plan to arrive outside of these hours.

Rates:

All rates shown are based on 2 guests. All additional guests will be charged per person per night. Failure to advise and pay for additional guests may result in your reservation being cancelled.

Deposits:

Off peak: A deposit of 2 night's stay is required at the time of booking.

Shoulder and Peak Season: A deposit of 4 night's stay is required at the time of booking.

Full Payment:

The balance payment for your stay is payable on arrival, except for Christmas, Easter and Weekend Packages in which payment is due prior:

Christmas: full payment is due by October 31.

Easter: full payment is due by February 28.

Weekend Packages: full payment is due upon making a reservation.

Any reservations not paid for by this date will be cancelled and the deposit refunded, less an administration fee.

Credit card guarantee:

A credit card must be produced in the name of the person staying at the park on arrival. Photo ID may be requested. Your credit card number will be held by an encrypted link for the duration of your booking and stay.

Key Deposits:

A \$30.00 boom gate tag and \$20.00 amenities key credit card guarantee will be held. Failure to return, loss or damage of tag or keys will result in a charge to your credit card for replacement.

Cancellation and Refund Policy:

To obtain a refund of deposits or fees paid, confirmation in writing/email of the cancellation is to be sent to the holiday park, a minimum of 7 days in advance of the booking.

- All refunds will incur a \$40.00 administration fee.
- Changes can be made to an existing reservation in the Off-Peak Period with sufficient notification, allowing the parks time to re-let the accommodation.
- For a request to change or cancel a reservation that provides less than one (1) week notice, Un-Relet Fees shall be charged.
- All fees are forfeited for no shows.
- Should people vacate a site early due to weather conditions, no refund will be given.

Receipts:

Please retain the receipt issued to you on arrival. This validates your length of stay. Please check that your arrival and departure date are correct.

Minimum Stays & Requirements:

- Off peak - minimum stay is 2 nights.
- Peak - minimum stay is 7 nights.
- Shoulder - minimum stay is 4 nights.
- Single Night Surcharge of \$40 applies for cabin accommodation.
- Friday & Saturday Night Surcharge of \$10 per night applies only to off-peak reservations less than 7 nights in cabin accommodation.
- Extra Persons 10 years and older in site accommodation are charged \$15.
- Extra Persons 5 years and older in cabin accommodation are charged \$15.

Site Guarantee:

Whilst we will make every endeavour to accommodate you on your selected site or cabin, it is not guaranteed. Occasionally it may be necessary to move a reservation to another site or cabin for operational reasons.

Future Bookings:

All bookings can be made 1 year in advance and are taken on a first come, first served basis.

Pets:

Tweed Coast Holiday Parks enforce a no pet policy at all parks. Exceptions may be made for "assistance animals" where proof of the animal's status to alleviate the effect of a guest's disability is provided.

Supervision of Children:

All children under 10 years must be accompanied by an adult when visiting the amenities.

Play Equipment & Sporting Facilities:

Bicycles, scooters, skateboards, etc must only be ridden during daylight hours on the roads within the park at no more than 10 kph. Please ensure the appropriate safety equipment is worn at all times.

Risk Warning:

Engaging in recreational activities are done so at your own risk.

Noise:

Please be respectful of the enjoyment of others within the park by restricting noise from television, music and social gatherings between the hours of 9pm and 8am. After 10pm: Silence is Golden.

Smoking:

Please note that smoking is not permitted in any accommodation, park facilities or in and around the community areas.

Open Fires:

Open fires are not permitted.

Surveillance Cameras:

Please be aware that surveillance cameras are used within our property.

Damage:

Any damages caused to park property or equipment will be charged to the guest.

Visitors:

All visitors should be registered on arrival. Guests are also responsible for their visitor's behaviour. Any visitor that stays overnight must be registered prior to staying (fees apply).

Electrical Connection:

Electrical leads connected to our power outlets must be 15 AMP tested and tagged. The use of double adaptors is not allowed.

Vehicle Length:

Sites will be allocated based on the measurements provided during the booking process. It is the responsibility of the guest to ensure dimensions are as accurate as possible. If you are unsure, please call the park directly. The measurement of a caravan/campervan includes the draw bar, bumper bar and any items hanging over the bumper.

Site Setup:

- **Minimum distance from site boundary - 1.25 metres.**
- **Exception - Minimum distance from roadway - 1.00 metre.**
- **Minimum distance from other caravans, tents or camper trailers either on the same site or adjacent sites - 2.50 metres.**
- **Tarpaulins can cover a maximum of 2/3 of the site area.**

As all site sizes vary, please discuss your requirements with park staff when booking a site.

Parking:

One car park is allocated per site or cabin. Additional cars must be parked in the visitor's car park. Please advise reception upon booking if you have a boat or trailer.

10kph Speed Limit:

Speed is to be limited to 10kph and directional signs must be observed.

Boom Gates:

Please do not tail gate through the boom gate after another vehicle or use the tag to gain entry for unauthorised vehicles. Failure to comply with this will result in the boom gate tag being turned off.

Your Site:

Must be kept tidy and discharge of sullage water and rubbish disposed of.

Garbage & Recycling:

Bins are located throughout the holiday park. Your assistance by observing the recycling signs prior to disposal is appreciated.

Under Age Bookings:

Tweed Coast Holiday Parks recommend to the park managers that any group booking by minors (4 or more under 18-year old's) must have a responsible adult present. A responsible adult is deemed a parent or teacher as typically an eighteen-year-old is part of the group and would not be deemed responsible in terms of answering for behavioral issues that may arise within the group.

Park Management:

It is a condition that all reasonable direction given by park management must be followed by guests and their visitors.

Booking Terms:

Tweed Coast Holiday Parks does not have a formal policy on the circumstances when a booking can or can't be refused. As a rule, it is at the discretion of the Park Manager if any booking is accepted or not.

Not Allowed:

The following is not allowed under any circumstances:

Illegal drug use; Excessive use of alcohol; Undue mess around site; Unregistered overnight guests; Undue noise; Acts of violence or abuse; Smoking in accommodation; Unregistered vehicles.

Emergency Evacuation Plan:

Please make yourself familiar with our emergency evacuation plan in case of an unforeseen emergency. Emergency Evacuation information is located in the guest information booklet in cabins and available to view at Reception. In case of an emergency, please remain calm and follow instructions from staff.
